PREMIUM ASSISTANCE UNDER MEDICAID AND THE CHILDREN'S HEALTH INSURANCE PROGRAM (CHIP)

If you or your children are eligible for health coverage from your employer, but are unable to afford the premiums, your state may have a premium assistance program that can help pay for coverage, using funds from their Medicaid or CHIP programs. If you or your children aren't eligible for Medicaid or CHIP, you won't be eligible for these premium assistance programs but you may be able to buy individual insurance coverage through the Health Insurance Marketplace. For more information, visit www.healthcare.gov.

If you or your dependents are already enrolled in Medicaid or CHIP and you live in a state listed below, contact your state Medicaid or CHIP office to find out if premium assistance is available.

If you or your dependents are NOT currently enrolled in Medicaid or CHIP, and you think you or any of your dependents might be eligible for either of these programs, contact your state Medicaid or CHIP office or dial **1-877-KIDS NOW** or **www.insurekidsnow.gov** to find out how to apply. If you qualify, ask your state if it has a program that might help you pay the premiums for an employer-sponsored plan.

If you or your dependents are eligible for premium assistance under Medicaid or CHIP, as well as eligible under your employer plan, your employer must allow you to enroll in your employer plan if you aren't already enrolled. This is called a "special enrollment" opportunity, and **you must request coverage within 60 days of being determined eligible for premium assistance**. Asistencia de Prima Bajo Medicaid y Programas de Seguro de Salud de Niños (CHIP)

Si usted o sus niños son elegibles para la cobertura de salud de parte de su empleador, pero no tienen los fondos para pagar las primas, su estado puede tener un programa de asistencia que pudiera ayudar a pagar las primas para la cobertura, utilizando fondos de sus programas de Medicaid o CHIP. Si usted o los niños no son elegibles para Medicaid o CHIP, no serán elegible para estos programas de asistencia para las primas, pero usted puede de comprar cobertura de seguro individual a través del mercado de Seguros de Salud (Health Insurance Marketplace). Si usted y sus dependientes ya están inscritos en Medicaid o CHIP y usted vive en un estado nombrado abajo, usted puede comunicarse a la oficina estatal de Medicaid o CHIP para averiguar si la asistencia para pagar las primas mensuales está disponible.

Si usted o sus dependientes NO están inscritos en Medicaid o CHIP, y usted piensa que usted o alguno de sus dependientes podría ser elegible para cualquiera de estos programas, usted puede llamar a la Oficina Estatal de Medicaid o CHIP o marque 1-877-KIDS NOW o www.insurekidsnow.gov para averiguar cómo aplicar. Si usted califica, puede preguntar a su Estado si este tiene un programa que le podría ayudar a pagar por las primas mensuales para un plan de salud patrocinado por el empleador.

Si usted o sus dependientes son elegibles para la asistencia de primas bajo Medicaid o CHIP, así como elegibles bajo su plan de parte del empleador, el empleador debe permitirle inscripción en el plan de su empleador si es que aún no está inscrito. A esto se le llama oportunidad “inscripción especial”, y usted deberá pedir la cobertura dentro de 60 días que se determine que usted es elegible para la asistencia.
